





Approval requests must be submitted to the CLE Committee by Friday, December 13, 2019. Fill and Sign your certification below.**
- (2) Deliver your packet to the **SUPREME COURT OF GUAM** on or before **January 31, 2020**.
- (3) This form along with your CLE packet can be uploaded at www.guambar.org for record keeping purposes by following the instructions on the website.

NOTE: Section 4(a) of the CLE Rule states as follows: "No member may submit a Certification of Attendance after January 31 without approval of the Supreme Court of Guam upon written request by the member." **The GBA Office is not authorized to accept untimely certifications; no certifications will be permitted for upload starting February 1.** Members will be allowed to upload CLE forms throughout the year.
